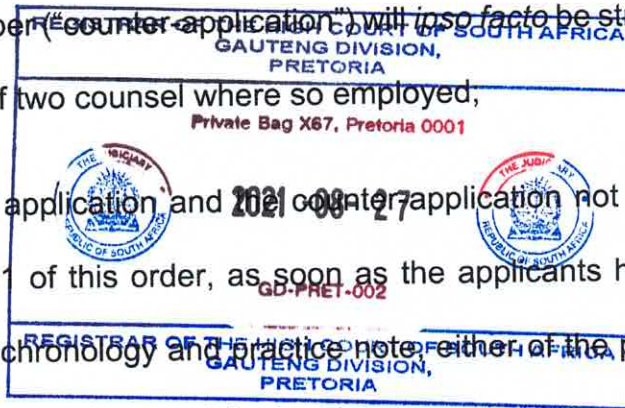

By agreement the following order is made:

1. The applicants will deliver their heads of argument, chronology and practice note in the main application under the above case number ("main application") by 8 September 2021, failing which, the main application and counter-application under the above case number (~~counter-application~~) will *inso facto* be struck out, with costs, including the costs of two counsel where so employed;
2. Subject to the main application and ~~2021-098-27~~ counter-application not being struck out in terms of paragraph 1 of this order, as soon as the applicants have delivered their heads of argument, chronology and practice note, either of the parties can apply to enrol the matter on the opposed roll for hearing;
3. The issue of costs relating to the interlocutory application under the above case number is reserved;
4. In regard to the counter-application:
  - 4.1. Subject to the main application and the counter-application not being struck out in terms of paragraph 1 of this order, the counter-application will be adjudicated with the main application.
  - 4.2. The issue of costs relating to the counter-application is reserved;



- 4.3. The first to third respondents will deliver their supplementary answering affidavit, if any, by 8 September 2021;
- 4.4. The applicants will deliver their replying affidavit, if any, by 22 September 2021;
- 4.5. The applicants will deliver the index by 29 September 2021;
- 4.6. The applicants will deliver their practice note, heads of argument and chronology by 13 October 2021; and
- 4.7. The first to third respondents will deliver their practice note and heads of argument by 27 October 2021.
