RE: REPORT ON THE PROGRESS OF THE BUSINESS RESCUE PROCEEDINGS OF EDCON

## Introduction

- In terms of section 132(3) of the Companies Act 71 of 2008 ("Act"), if a company's business rescue 1. proceedings have not ended within three (3) months after the start of those proceedings, or such longer time as the Court, on application by the practitioner, may allow, the practitioner must -
  - 1.1. prepare a report on the progress of the business rescue proceedings, and update it at the end of each subsequent month until the end of those proceedings; and
  - 1.2. deliver the report and each update in the prescribed manner to each affected person, and to the:
    - 1.2.1. Court, if the proceedings have been the subject of a court order; or
    - 1.2.2. Commission, in any other case.
- 2. Therefore, as required, this **Update Report** is being delivered by the business rescue practitioners of Edcon ("BRPs") in terms of section 132(3) of the Act.
- 3. Reference is made in this Update Report to the adopted business rescue plan ("Plan"). Any capitalised terms not defined herein shall have the meaning ascribed to same in the Plan. It is therefore important that this Update Report be read in conjunction with the Plan and the previous update reports.

## **Business Rescue Proceedings**

- 4. Edcon's Subsidiaries in Africa ("Subsidiaries")
  - 4.1. The BRPs intend on commencing with the formal winding-up of the Subsidiaries.
  - 4.2. Affected persons will be advised of further developments in due course.

## 5. Legal Proceedings

- 5.1. As indicated in the previous update report, the application for leave to appeal to the Supreme Court of Appeal brought by Kingsgate Clothing (Pty) Ltd and 7 Others ("applicants") was dismissed with costs ("SCA decision").
- 5.2. On 12 September 2022, the applicants made an application to the Judge President of the Supreme Court of Appeal, in terms of Section 17(2)(f) of the Superior Courts Act, 10 of 2013, requesting that the SCA decision be referred for consideration and, if necessary, variation.
- 5.3. The parties have filed their affidavits and affected persons will be notified of the outcome.

## Conclusion

- 6. The BRPs will continue implementing the Plan in accordance with their statutory obligations.
