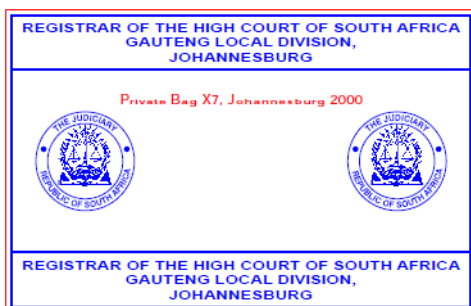

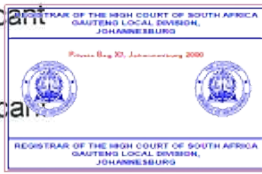
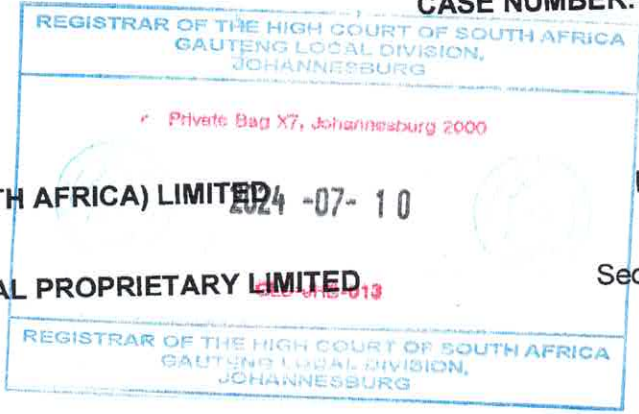

ORDER

Having read the papers filed of record and having heard counsel, it is ordered that:

1. This application is heard as one of urgency.
2. The first applicant (acting on its behalf and on behalf of the second applicant) alternatively the first applicant's duly authorised agent, alternatively the Sheriff of

the High Court ("Sheriff"), is authorised to perfect the general notarial bonds under bond numbers BN21016/2023 and BN26594/23 ("GNBs"), and in particular to enter in and upon all of the respondent's premises and the premises of any third party where the respondent's assets may be found, and to take possession and hold in pledge all of the movable assets of the respondent, wherever situate.

3. The perfection of the second applicant's general notarial bond under bond number BN26594/23 is limited to the respondent's assets situated within the Pretoria deeds registry area.
4. The applicants are granted leave to approach this Court on these papers as may be amplified for further relief in respect of the GNBs.
5. The applicants, alternatively the Sheriff, are authorised to serve and execute this order by way of an emailed copy.
6. The respondent is ordered to pay the costs of this application on an attorney and own client scale.
