UPDATE REPORT - BUSHVELD VAMETCO HOLDINGS (PTY) LTD (“BVH”)

1. Introduction

- a. In terms of section 132(3) of the Companies Act 71 of 2008 (“**Act**”), if a company’s business rescue proceedings have not ended within three (3) months after the start of those proceedings, or such longer time as the court, on application by the practitioner, may allow, the practitioner must –
 - i. prepare a report on the progress of the business rescue proceedings, and update it
at the end of each subsequent month until the end of those proceedings;
and
 - ii. deliver the report and each update in the prescribed manner to each affected person,
and to the:
 1. court, if the proceedings have been the subject of a court order; or
 2. Commission (“**CIPC**”), in any other case.
- b. We therefore address this status report to you on behalf of BVH and in compliance with the provisions of section 132(3) of the Act.

2. Business Rescue Proceedings

- a. During February 2026, the BRPs continued to administer the business rescue process in line with the adopted plan.
- b. Engagement with management and stakeholders remained ongoing to monitor developments affecting the Company and the broader group.
- c. The Company remains under care and maintenance, with focus on asset preservation and compliance.
- d. There have been no substantive developments in relation to the Uitvalgrond Community litigation and the BRPs continue to consider the arbitration proposal.
- e. Affected persons are encouraged to remain engaged and to contact the BRPs if required.

4. Claims

- a. Creditors are required to lodge their Claims with the BRPs as soon as possible if they have not already done so, in any event before 25 July 2025.
